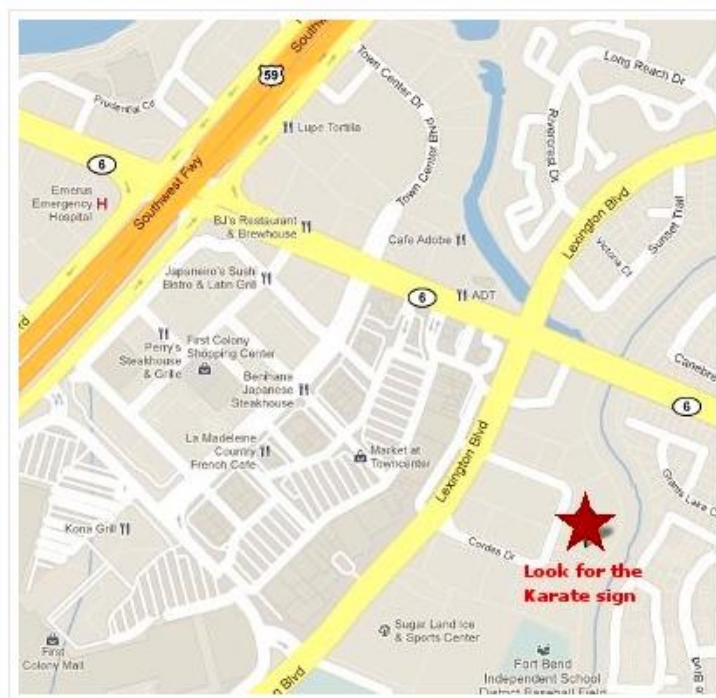
About Houston Ki-Aikido dojo
