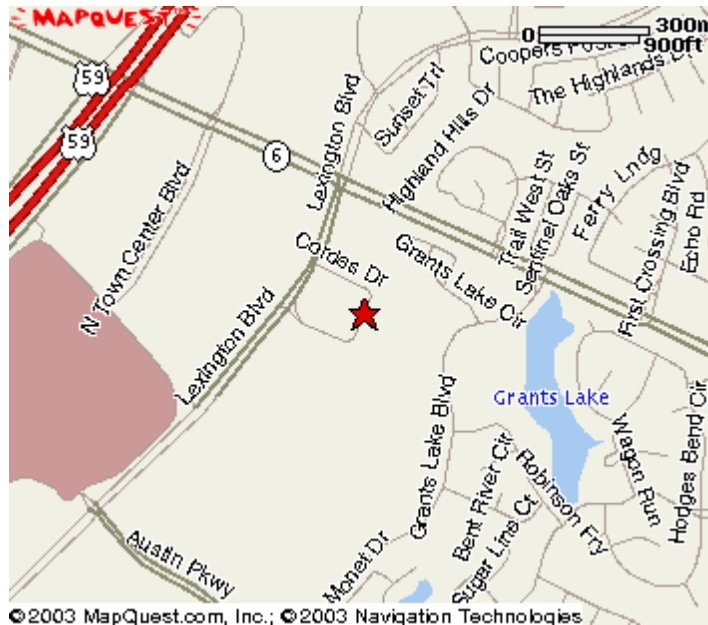
About Houston Ki Aikido
