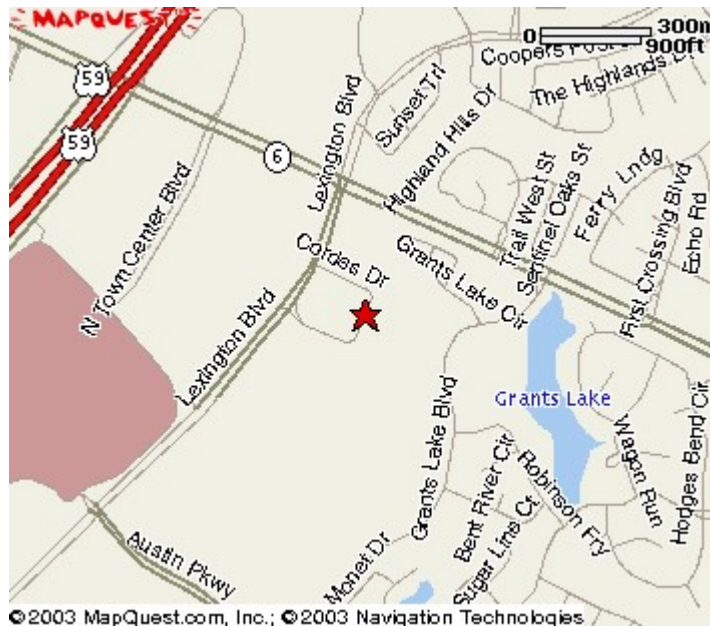
## About Houston Ki Aikido
